- 059/16 **Minutes** The Chairman was authorised to sign the minutes of the meeting held on the 5th September as a true record.
- 060/16 **Public Participation.** A member of the public raised issues regarding the status of Neighbourhood planning, the need for a website to promote the area and the tourism development opportunities raised by the Yorkshire Dales National Park. The idea of a specific liaison person on the council was suggested. Cllr Hughes suggested that a Neighbourhood development order might be an easier process. It was agreed not to progress Neighbourhood planning for a period of 2 years or until the Yorkshire Dales National Park Development plan had been progressed.

063/16 **Phone box decommissioning.** David Graham had met with the MP at a surgery over the issue. It had been difficult to argue against the closure because of the low volume of calls but a further update was awaited. It was hoped that an outcome could be secured in which emergency call units were installed in the boxes at the expense of BT. The Parish Council would adopt the service charge currently £1 a week each to be reviewed annually.

064/16 **Highways.** The position regarding Brackenslack was restated (needs action to drain water to the other side of the road), Maulds Meaburn Cattlegrid (lowered) Oddendale Cattle Grid (Lowered and need of clearing) Standing water at the Sun Hotel (an issue for the householder's perimeter defences), The cattle grid at Meaburn Edge was noted. All were marked for action by Highways. Cllr Hughes undertook to look into a question of a stile at Reagill raised by a member of the public.
