Unfortunately it seems that it is impossible to communicate direct with your organisation by email other than as a customer. I could not find any simple email address on your website.

Crosby Ravensworth Parish Council is the owner of Maulds Meaburn Village Green through which flows the River Lyvennet.

United Utilities appears to have a water main across the river (blue alkathene pipe in a cast iron pipe). This was originally embedded in the river stone but over recent years with regular floods the pipe has become increasingly exposed.

It is now sitting fully exposed, twisted, and damaged at one end. In addition a further alkathene water supply pipe has been exposed in the river bank downstream of the water main crossing.

The water main is causing disturbance of the river flow when in flood and we feel it is having an impact on the downstream riverbank causing increased erosion. The pipe is also now vulnerable to snagging by large tree branches and the odd tree that regularly wash down the river in severe floods.

We have numerous photographs which we would be happy to forward.

Could we also arrange a site meeting to discuss your proposals to rectify the issue before it becomes more serious. Residents are well aware of the problems associated with the water main damage SW of Shap and the consequences for customers.
